## KEEP YOURSELF SAFE FROM MEDICARE FRAUD

- Guard Your Medicare Number: Treat it like a credit card number. Never give it out over the phone to unsolicited callers emails or texts.
- Beware of Free Offers: Scammers often promise free medical equipment or testing. Legitimate Medicare representatives will never call you to offer free items.
- Check Your Statements: Regularly review your Medicare Summary Notice (MSN) or Explanation of Benefits (EOB) for unfamiliar charges. Reporting any discrepancies quickly can help stop fraud.

- Legal names of all people included in the application
- Social Security cards
- Proof of Address: Utility Bills (i.e. PG&E), insurance documents, etc.
- Proof of Identity: Passports, driver's license, etc.
- Income information: Social Security Award letter, pay stubs, etc.

Disclaimer: Please bring all documents enclosed in a secure folder. Do not share documents/personal information with anyone other than the Eligibility Worker on site.

#### Fill out the initial application for Fresno County

Eligibility is income-based.

138% of the federal poverty level (FPL) is what will be used to determine whether uou qualify for Medi-Cal.

Families or persons with income too high to qualify for a free Medi-Cal program may have a Share of Cost.
